



Sonia Tanti Independent Living Centre

DESCRIPTION

What does this service include?

- A helpline that will guide disabled persons who phone or email the STILC regarding equipment and services that are best suited for their needs. Furthermore, persons with disability who require further assessment at the Sonia Tanti Independent Living Centre may call Helpdesk for an appointment.
- Assessments and Advice on Wheelchair and Seating Systems. This Unit within the Sonia Tanti Independent Living Centre assists persons with disability to purchase a wheelchair by providing them with advice and assessment on which wheelchair/cushion mostly suits their needs.
- Adapted Driving Assessment and Training Unit. A driving assessment may be carried out on persons with disability who wish to drive. Furthermore, driving lessons on modified cars may also be provided to persons with disability who are fit to drive, by

qualified persons who have been trained in this area.

- Adaptive Equipment Demonstration and Assessment Unit. This Unit within the Sonia Tanti Independent Living Centre assists persons with disability to purchase assistive equipment by providing them with advice and assessment on which assistive equipment mostly suits their needs.

How is the service provided?

The service is provided in Malta and in Gozo. Persons with disability may phone KNPDP helpdesk for further information or for an appointment at the Sonia Tanti Independent Living for an assessment or training.

ELIGIBILITY

Who can apply?

Persons with disability who have been referred to the Sonia Tanti Independent Living centre can contact Helpdesk for an appointment.

Brief overview of service
Thanks to the Sonia Tanti Independent Living Centre at Hal Far (STILC), the National Commission Persons with Disability (KNPD) provides persons with disability and their families with advice, information and training in aspects of independent living such as mobility and assistive technology. Following their training at the ILC, disabled persons may be referred to employment and training opportunities that may be suitable for them. These services would empower persons with disability in Malta and Gozo to be well prepared for the world of work and to be fully integrated in society. This Centre has been part-financed by the European Regional Development Fund (ERDF 072 Project).

X' jinkludi dan is-servizz?

- Helpline, li hu servizz ta' konsulenza li permezz tiegħu persuni b'diżabilità jkunu jistgħu jċemplu jew jibgħatu emails dwar diffikultajiet li jiltaqgħu magħhom fl-aspetti kollha ta' għixien indipendenti, kif ukoll biex jingħatalhom appuntament għal assessment jew pariri f'dan iċ-Ċentru.
- Assessjar u pariri dwar Wheelchairs u Seating Systems. Permezz ta' din il-unit, persuni li jkollhom bżonn jixtru wheelchair jista' jsirilhom assessment dwar x'tip ta' wheelchair/cushion l-aħjar li jixtru.
- Assessjar u taħriġ dwar sewqan b'vetturi adattati. Persuni b'diżabilità li jixtiequ jsuqu jista' jsirilhom driving assessment f'dan iċ-Ċentru. Persuni b'diżabilità li jistgħu isuqu jistgħu jingħataw lezzonijiet ta' sewqan fuq karozzi modifikati minn persuni kwalifikati li rċevew taħriġ f'dan il-qasam.
- Assessjar u pariri dwar apparat li jintuża biex jgħin persuni

b'diżabilità fl-attivitajiet tagħhom tal-hajja ta' kuljum. Persuni b'diżabilità jkunu jistgħu jiġu f'dan iċ-Ċentru u jiprovaw diversi apparat assistiv sabiex jaraw liema hu l-aħjar apparat għalihom.

Kif jingħata s-servizz?

- Is-servizz jingħata kemm f'Malta kif ukoll f'Għawdex. Persuni b'diżabilità jistgħu jċemplu lil Helpdesk tal-Kummissjoni Nazzjonali Persuni b'Diżabilità u tingħatalhom iktar informazzjoni dwar dawn is-servizzi jew appuntament meta jistgħu jżuru t-Taqsima Hajja Indipendenti Sonia Tanti biex isirilhom assessment jew jingħatalhom taħriġ.

ELIĠIBILTÀ

Min jista' juża dan is-servizz?

- Persuni b'diżabilità li jiġu referuti għal dan is-servizz jistgħu jċemplu lil Helpdesk u jingħatalhom appuntament meta jistgħu jżuru t-Taqsima Hajja Indipendenti Sonia Tanti.

Is-servizz fil-qosor

Permezz tat-Taqsima Hajja Indipendenti Sonia Tanti (STILC) ġewwa Ħal-Far, il-Kummissjoni Nazzjonali Persuni b'Diżabilità (KNPD) tipprovi servizz ta' pariri, informazzjoni u taħriġ lil persuni b'diżabilità u l-familji tagħhom f'aspetti ta' għixien indipendenti, b'mod speċjali l-mobilità u apparat assistiv.

Wara li jkunu rċevew il-pariri u t-taħriġ fl-iSTILC, il-persuni b'diżabilità jistgħu jingħataw taħriġ dwar opportunitajiet ta' taħriġ u skemi fil-qasam tax-xogħol.

Għaldaqstant, dawn is-servizzi huma strument importanti li bih il-persuni b'diżabilità f'Malta u Għawdex jaslu għal aktar inklużjoni fis-setturi tax-xogħol, l-educazzjoni u l-hajja soċjali. Din it-Taqsima giet ko-finanzjata mill-Fond Ewropew għall-Iżvilupp Reġjonali (Proġett ERDF072).
