



# Special Identity Card and the Register of Persons with Disability

## THE SPECIAL IDENTITY CARD

### Eligibility

#### Who can apply for the SID?

If you are a person with disability, irrespective of gender and age, as defined by the Equal Opportunities (Persons with Disability) Act 2000, then you may be entitled for the SID.

### Procedure

#### What should I do?

If you fulfil all the eligibility criteria, you should fill in the appropriate application form, which is available from KNPD.

## DOCUMENTS REQUIRED

### What do I need?

1. A Doctor Certificate
2. Two passport size photographs, one of which should be endorsed by a professional person.

## CARD BENEFITS

### How and where can the SID be used?

There are places which give priority, according to need, to disabled persons who are holders of the SID. Other places offer subsidies on membership or on entrance fees. One should check about this with the relevant place.

## REGISTER OF PERSONS WITH DISABILITY

### Description

#### What does this service include?

The list of persons with disability registered with KNPD can be used to:

- Collect statistics in order to help in the formulation of policies and research.
- Provide persons with disability and their families with up to date information so that they will be in position to make informed decisions.
- Enable organisations and individuals to communicate with persons with disability and /or their families.

## ELIGIBILITY

### Who can be in this Register?

Any person who qualifies for a SID issued by KNPD can be in this Register.

### Who can use the data in this Register?

Any organisation or individual who would like to communicate with persons with disability and their families who are registered with KNPD, can make use of this service.

## CONFIDENTIALITY

KNPD is bound by the Equal Opportunities Act (Persons with Disability) to respect in the strictest way the confidentiality of information which the KNPD has concerning persons with disability and their families. In no way can private information about persons with disability and their families be divulged to any organisation or individual.

## PROCEDURE

### What should I do to be included in this Register?

Every person who applies for a Special Identity Card at KNPD is asked to fill in a detailed questionnaire. The information is inputted in a computer and the confidentiality of persons registered is respected at all times.

### What should I do to use the data on the Register?

Organisations or individuals who would like to communicate with persons registered with the KNPD should follow this procedure:

## Brief overview of services

The National Commission Persons with Disability (KNPD) issues a Special Identity Card (SID) for persons with disability. The SID identifies one as a disabled person who can thus apply for further services. KNPD maintains a Register of Persons with Disability sorted by locality, gender, age and different impaired.

- A request in writing addressed to the Executive Director of KNPD.
- KNPD has to receive this letter together with the material to be sent, at least three weeks in advance.
- The material can be aimed at different categories of persons on the Register, that is by age, gender, locality, and impairment category.
- KNPD sends this material by post together with a note explaining this process and assuring full confidentiality. The note also specifies that the material being sent is the responsibility of the sender and not that of KNPD.
- All postage expenses are borne by the sender.
- Commercial organisations are also asked to cover other administrative expenses.

### Eligibilità

#### Min jista' japplika għall-Karta tal-Identità Speċjali?

Kull persuna b'dizabilità hi x'inh i s-sess jew l-età, hija intitolata għall-KIS jekk l-applikant għandu dizabilità kif inhi definita fil-Liġi Opportunitajiet Indaq (Persuni b'Dizabilità).

### Proċedura

#### X'għandi nagħmel biex napplika?

Jekk inti eligibbli għall-Karta tal-Identità Speċjali, tista' timla formola tal-applikazzjoni li tista' ggib mill-uffiċini tal-KNPD jew inkella fuq il-website tal-KNPD: [www.knpd.org](http://www.knpd.org)

### X' għandi bżonn?

- Ċertifikat tat-tabib mimli li jinsab il-formola tal-applikazzjoni
- Żewġ ritratti daqs ta' passaport reċenti – wieħed minnhom iffirmat minn professjonist/a.

## BENEFIĊĠI

### Fejn tista' tintuża l-Karta tal-Identità Speċjali?

Hemm postijiet li jagħtu prijorità fis-servizzi tagħhom skont il-ftieġa, lill-persuni b'dizabilità li għandhom il-KIS. Hemm ukoll postijiet li jagħtu sussidju fuq is-sħubija jew l-entrata. Wieħed għandu jiċċekkja dwar dan mal-post konċernat.

## IR-REGISTRU TAL-PERSUNI B'DIZABILITÀ

### X'jinkludi dan is-servizz?

Dan is-servizz jinkludi lista ta' persuni b'dizabilità registrati mal-KNPD li tintuża sabiex:

- Jinharġu statistiċi li jgħinu fit-tfassil ta' policies u fricierka.
- Jinzammu aġġornati l-persuni b'dizabilità u l-familji tagħhom bis-servizzi u informazzjoni oħra relatata mal-qasam tad-dizabilità.
- Organizzazzjonijiet u individwi jkunu jistgħu jikkomunikaw ma' persuni b'dizabilità u/jew il-familji tagħhom.

## ELIGIBILITÀ

### Min jista' jidhol f'dan ir-registru?

Kull persuna b'dizabilità li tikkwalifika għall-KIS tista' tidhol f'dan ir-registru.

### Min jista' juża d-data ta' dan ir-registru?

Kull organizzazzjoni jew individwu li tixtieq tikkomunika mal-persuni b'dizabilità u l-familji tagħhom registrati mal-KNPD tista' tagħmel użu minn dan is-servizz.

## KUNFIDENZJALITÀ

Il-KNPD hi marbuta bil-Liġi Opportunitajiet Indaq (Persuni b'Dizabilità) li żżomm bl-aktar mod strett il-kunfidenzjalità tal-informazzjoni li hi tircievi dwar persuni b'dizabilità u l-familji tagħhom. Għalhekk hi bl-ebda mod ma tista' tagħti xi informazzjoni privata dwar persuni b'dizabilità jew il-familji tagħhom lil xi organizzazzjoni jew individwu.

## PROĊEDURA

### X'għandi nagħmel biex nidhol fir-registru?

Kull persuna li tapplika għal xi servizz minn naħa tal-KNPD tiġi registrata awtomatikament f'dan ir-Registru. L-informazzjoni tingabar bil-kompjuter b'mod li titfares kompletament il-kunfidenzjalità tal-persuni registrati.

### X'għandi nagħmel biex nuża d-data tar-Registru?

Organizzazzjonijiet jew individwi li jixtiequ jikkomunikaw mal-persuni registrati mal-KNPD għandhom isegwu din il-proċedura:

- Trid issir talba bil-miktub (b'ittra jew permezz ta' email) lid-Direttur Eżekuttiv tal-KNPD. Flimkien mal-ittra tintbagħat kopja taċ-ċirkulari li tkun se tintbagħat lill-persuni b'dizabilità
- Il-materjal li jkun ser jintbagħat lill-persuni b'dizabilità irid jasal għand

Bil-KIS persuna tista' tapplika għas-servizzi miftuħa għall-persuni b'dizabilità. Il-KNPD iżżomm registru ta' persuni b'dizabilità imqassmin skont il-lokalità, sess, età u kategoriji differenti ta' dizabilità.
