DESCRIPTION

What does the Equal Opportunities Act (Persons with Disability) entail?

This Act aims towards a goal of “a society where all disabled people can participate fully as equal citizens.” It puts into force the legal rights and obligations affecting disabled persons. These cover the areas of employment, education, access, goods and services, housing and insurance.

What does the Unit do?

The Unit:

- Provides advice and information about this field;
- Supports disabled people in securing their rights under the Equal Opportunities Act;
- Works to change policy, practice and awareness so that disabled people get a fairer deal;
- Registers and investigates alleged acts of discrimination on the basis of disability, negotiates an equitable solution and, only as a last resort, seeks redress through the Courts.

ELIGIBILITY

Who can make use of this Service?

- Persons with Disability
- Their Families
- Disabled Persons’ Organisations
- Service Providers and Employers

PROCEDURE

What do I do if I have a complaint?

- Contact in writing (by email or letter) the entity concerned, describe the act of discrimination

and ask the required remedial action is implemented within a reasonable timeframe. KNPD has prepared a sample letter to facilitate this.

- If progress is not registered, fill in a formal complaint form.
- Copies of both sample letter and the complaint form are available on KNPD’s website: www.knpd.org and from KNPD’s Secretariat.

FORMAL COMPLAINT PROCEDURE

When a written complaint is received,

- An acknowledgement is sent.
- The Unit considers the complaint. If the complaint cannot be justified, the applicant will be advised in writing together with possible alternative remedies.
- If the complaint can be justified and prima facie discrimination has occurred, the Unit will investigate the complaint.
- A notice of complaint will be sent to the defendant asking for further comments. This will help the Unit reach a provisional view.
- If the complaint is considered justified, the defendant will be asked to submit a proposal including a timeframe, indicating how and when the

Brief overview of service
The National Commission Persons with Disability (KNPD) established the Equal Opportunities Compliance Unit (the Unit) within its Secretariat, charged with promoting equality of opportunity and implementing the provisions of the Equal Opportunities Act (Persons with Disability) which came into effect on the 1st October 2000, and thus investigates acts of discrimination on the basis of disability.

- Tagħti support;

- Jekk ma jsirx progress imla formola ta' lment u ibagħta lill-KNPD.
- Qafas tal-ittra u il-formola tal-ilment jistgħu jinkisbu mis-Segretarjat tal-KNPD, u tista' ukoll issaqsi għall-għajnuna biex timtela l-formola.

PROĊEDURA FORMALI TAL-ILMENT

Meta t-Taqsima tirċievi ilment bil-miktub,

- Tibgħat acknowledgement
- It-Taqsima tikkunsidra l-ilment. Jekk l-ilment ma jkunx ġustifikat, l-applikant jiġi nformat bil-kitba flimkien ma' rimedji alternattivi possibbli.
- Jekk prima facie tidher li kien hemm diskriminazzjoni, it-Taqsima tibda tinvestiga l-ilment
- L-ilment jintbagħat lill-entità kontra min sar l-ilment għal kummenti tiegħu. B'hekk it-Taqsima tkun tista' tiffirma opinjoni proviżorja.
- Jekk l-ilment jiġi kkunsidrat bħala ġġustifikat, din l-entità tkun mitluba tagħmel proposta li tinkludi timeframe, li tindika kif u meta, il-modifiki necessarji biex titneħħa d-diskriminazzjoni se jsiru.
