What are the aims of the Resource Centre?

The aims of the Resource Centre are:

- To provide the general public and especially persons with disability and their families and other individuals who work in this sector, with updated information in order to keep them abreast with disability matters in Malta and abroad
- To publish material produced by the Commission in written form and also in alternative media, such as: Braille, Large print, on audio and on CD's and DVD' s with sign language.
- To provide information about assistive apparatus for persons with disability.

REFERENCE SECTION

The Resource Centre has a Reference Section with books like directories, dictionaries, theses, etc. Members can consult these books only in the Resource Centre itself, because books from this section cannot be borrowed.

MEMBERSHIP

How can I become a member?

The service of the Resource Centre is free of charge. To become a member all you have to do is fill in an application form with your details and bring your ID Card. As a member of the Resource Centre you can borrow up to five items a month. The loans can be renewed by telephone.

DESCRIPTION

What will I find in the Resource Centre?

The material in the Resource Centre focuses on the social aspect of disability, that is, how society creates obstacles for persons with disability and how these obstacles can be removed.
