Continuous Education, Training & Research Programme

DESCRIPTION

What is the aim of this programme?

The aim of PEKTUR is to encourage disabled persons registered with KNPD to continue their education, training or research particularly in priority areas defined by KNPD from time to time.

ELIGIBILITY

Who can apply for financial aid?

Disabled persons registered with KNPD may apply.

THE SELECTION PROCESS

- A decision is taken by an autonomous Selection Board.
- The applicants are informed in writing of the Board's decision
- If the project is chosen, then conditions upon which financial aid is granted are agreed upon and payment is only affected upon presentation of relevant receipts.

THE PROPOSAL

Details for the layout of the proposal can be found on KNPD's website or from the KNPD's Secretariat. You should present two copies of your proposal to the Board. These should include:

- A detailed proposal of not more than 1,000 words

- The Curriculum Vitae of the applicant
- Budget

SELECTION CRITERIA

Does the project:

- Fall within our priority areas?
- Have clear and important aims?
- Leave direct or indirect benefits?
- Is the project practical?
- Can the project be completed in a reasonable time?
- Does it have a reasonable budget?
- Does the project make use of other resources (financial contributors, etc)?

SPEAK OUT!

Through PEKTUR KNPD organises Speak Out!. This comprises a number of short training courses organised by KNPD and aimed at disabled activists and parents of persons with an intellectual impairment. The aims of the courses differ according to the needs which KNPD recognises as priorities at the time. Speak Out!

Brief overview of service
PEKTUR is a programme, of the National Commission Persons with Disability (KNPD), which provides limited financial support concerning continuous education, training and research within the disability field, by disabled individuals registered with KNPD, it organises short training courses for disabled activists and parents of persons with intellectual disability and financially support research undertaken by KNPD.
